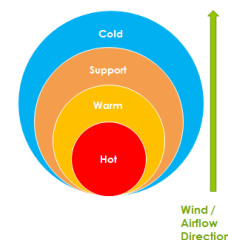
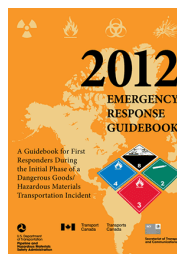

Hands-on Training

- **Incident Reporting** - Reporting requirements at the federal, state and local level are covered based on your location and chemical inventory.
- **Custom Environmental Protection Exercises** - Our practice exercises focus on potential environmental situations unique to your facility.
- **Custom Emergency Response Exercises** - We develop hands on training responding to emergency incidents based on your facility and hazards.
- **Incident Command System (ICS)** - employees are taught the essentials of ICS and get the chance to perform the duties of incident commander during practice exercises.
- **Decontamination** - We develop practical hands-on decontamination exercises.
